



2022 Legislative Advocacy Highlights

Gov. Ron DeSantis signed a record \$109.9 billion budget for FY 22-23 beginning July 1, 2022. Here is the summary of FCEH legislative priorities:

Priority 1: Increase Homeless Recurring Staffing Grant

Homeless Staffing Grant was funded at its current rate of \$3 Million in recurring General Revenue (GR) for FY 2022-2023.

Priority 2: Maintain Current Recurring Challenge Grant Funding

Challenge Grant was funded at its recurring amount of \$3.1 M.

Priority 3: Affordable Housing Trust Fund

The final budget included \$362,725,000 for affordable housing, which is the largest housing total since FY 2007-2008.

2023 Legislative Advocacy

The Advocacy Committee is currently working on finalizing suggestions for CoC Member Agencies and they will vote to approve the 2023 FCEH Legislative Priorities.

FCEH has already started the Legislative Budget Request (LBR) process for the 2023 Legislative Session requesting that DCF include an LBR issue to increase homeless funding by \$7,354,984. Of this, \$2,104,984 would go towards increasing the Staffing Grant. Based on the CoCs staff turnover and inadequate staffing, the increase is necessary to maintain a fully operational CoC system in the State of Florida. The remaining \$5,250,000 would go to support at least seven permanent housing projects for individuals experiencing homelessness per year. This would allow CoCs to determine the construction or rehab project to serve their hardest to house clients seeking housing. Agency LBRs shall be submitted no later than October 15th.

HOME American Rescue Plan (ARP)

CoCs are encouraged to get ahead of HOME-ARP allocations to combat homelessness in their communities. HOME-ARP resources can be used for Tenant-Based Rental Assistance, Supportive Services, and acquiring, rehabilitating, or constructing affordable rental housing. Participating Jurisdictions (PJs) that receive HOME-ARP funds should be encouraged to work with their CoC and establish homeless preferences for populations such as chronically homeless individuals and families or elderly persons with disabilities experiencing homelessness. Referrals can come through the CoC's Coordinated Entry process. Read HUD's latest policy brief and notice on HOME-ARP.

Active 2022 Hurricane Season Expected

Hurricane Season has begun and 2022 is expected to be a very active season. Make sure your CoC has emergency plans in place to support contracted providers before, during, and after a hurricane. Take a proactive approach to ensuring vulnerable populations experiencing homelessness are not left behind. Hurricane season runs through November 30th, but activity peaks in late August through September, so it's not too late to get emergency plans in place.
